#### Notes

1. Suzion Green Power Limited (subsequently known as Suzion Towers And Structures Limited, and which eventually merged with Suzion Energy Limited) had borrowed Rs.5.89 Crore (which was subsequently reduced to Rs.5.55 Crore) and Rs.6.00 Crore from Indian Renewable Energy Development Agency Limited and State Bank of India respectively with charge IDs 90105217 and 90106673 respectively.

These borrowings had long been paid off on 15th April 2010 and 4th January 2006 respectively and necessary filings of satisfaction of the charge were made. However, due to some technical issues with the portal of the Ministry of Corporate Affairs ("MCA"), the same are still showing as open in the records of the MCA.

The copies of Form 17 for Indian Renewable Energy Development Agency Limited and State Bank of India respectively are hereto annexed and marked as "Annexure IA" and "Annexure IB".

Additionally, the Transferee Company also submitted letter dated 05 July 2022, for deletion of these incorrect charges from the index of charge, however the same has not been updated on the portal. Acknowledgement of such letter is enclosed as "Annexure II"

2. ANZ Grindlays Bank Ltd. is not traceable and hence necessary filings of satisfaction of the charge could not be made.
