## Suzlon's Generator Unit wins award at Manufacturing Today Summit

**Chennai, India:** Suzlon Energy Ltd. (BSE & NSE: SUZLON) India's largest renewable energy solutions provider won the Quality Improvement Project (QIP) competition on Cost Optimization at the 5th Annual Summit of Aditya Birla Group's Regional Competition on 'Reinventing the Future' organised by Manufacturing Today in Chennai.
